Notice Concerning the Results of GRESB Assessment

Frontier Real Estate Investment Corporation (the “Investment Corporation”) hereby announces that the Investment Corporation received an assessment rank of “5 Stars”, the highest rank in the GRESB Rating and a “Green Star” status for the six consecutive years in the GRESB Real Estate Assessment, as well as the highest “A Level” under the GRESB Public Disclosure Level Assessment.

1. Overview of GRESB

GRESB is an annual benchmark assessment to measure environmental, social, and governance (ESG) consideration of real estate companies and funds, as well as the name of organization which runs the assessment. It was established in 2009 primarily by major European pension funds groups, which lead the Principles for Responsible Investment (PRI).

Over 100 companies of investor members use GRESB data for their investment decision-making and engagement with investees, and several institutions from Japan including Government Pension Investment Fund (GPIF) utilize GRESB Assessment results. In 2020, 1,229 listed or private real estate companies and funds participated in GRESB Real Estate Assessment.

2. Results of GRESB Real Estate Assessment

The Investment Corporation received an assessment rank of “5 Stars”, the highest rank in the GRESB Rating, a five-grade relative evaluation of the overall GRESB score.

The Investment Corporation also received a “Green Star” status for the six consecutive years since it is highly evaluated in both aspects of “Management Component” that evaluates policies and organizational structure for ESG promotion and “Performance Component” that assesses environmental performance and tenant engagement of properties owned.



3. Results of GRESB Public Disclosure Level Assessment

The Investment Corporation received the highest “A Level” under the GRESB Public Disclosure, which assess the width of ESG disclosure.
